**Review of Minutes:** Minutes from January 29, 2009 meeting were reviewed and accepted.

### **Financial Report:**

General reserves balance - \$29,753.13

Unpaid dues for 2009 – 14 properties remain unpaid. Late letters have been mailed and late fees are assessing monthly.

### **Committee Reports:**

**ACC** – Notices were mailed regarding trailer parked in street. The trailer has been moved.

Scott Atwood has agreed to serve as the 3<sup>rd</sup> member of the ACC as a representative of the Board.

**Audit** – A chair is needed for this committee and this position will be posted on the web and in the newsletter. The audit needs to be completed by July for the annual meeting mailing.

**Communications** – 1<sup>st</sup> quarter newsletter went out on February 2nd; the 2<sup>nd</sup> quarter newsletter will go out in April. Any contributions should be forwarded to Sheri.

**Landscape** – Jerry Ryan re-keyed the irrigation box at the entrance. Jerry has one key and the Secretary/Treasurer has the second key. Jerry also repaired the fence at 305 Castle Hill.

### **Ongoing Business:**

**Website** – Emails are not going through – Raina will check on this. Minutes will be added to the website. Raina will email homeowners about the new website. A suggestion was made to include new homeowners in one of the front page boxes.
