Call to Order: 7:13 pm

Opening: The meeting was called to order by Scott Atwood. The following items were discussed:

Approval of previous Meeting Minutes

Scott submitted the meeting minutes of January 14, 2010 as email for approval. Lonnie made a motion to accept the meeting minutes. Sharon seconded the motion and the motion was passed unanimously.

Financial Report

Audit – Nothing to Report

Communications – Scott to get with Shari Campbell-Husband regarding the newsletter. Scott will update the "Letter from the Board". Shari needs some items for the newsletter. It was determined that the Budget was not required to be dissimulated and will not be included in the newsletter.

Landscape – Lonnie will notify Jerry Ryan of the possible irrigation leak at the Park. This was reported to Scott by the City of Burleson Water Department. Water was flowing down Alsbury and the City shut off the water at the meter.

Flags – Nothing to Report

Old Business:

Street Lights – Several street lights were out but were repaired by ONCOR within a couple of days after being notified on or about 01-22-10.

Police Patrol - Police have stepped up patrol in the area – particular intersection of FS & CH.

Unfinished Business:

305 Castle Hill Drive – No new progress to report at this time. However, the 2010 Dues were sent to the Mortgage Holder / Trustee as per the title records.

216 Flagstone – Dues for 2008 and 2009 are outstanding. The property is vacant and appears to be in foreclosure. The invoice for 2010 was sent out with the others on December 14, 2009 but there has not been any response. Lonnie made a motion to begin filing a lien against the property for past HOA dues and mowing of the property during the 2009 growing season. Sharon seconded the motion and the motion passed unanimously.

Irrigation - An irrigation head was leaking at the Entrance on the west side of Flagstone at the street light. Jerry Ryan repaired it.

By Law Ratification – A Special Meeting was called by Scott in order to approve the By-Laws. After discussion, Lonnie made a motion for the Special Meeting to be held on Tuesday, March 9 from 6:30pm to 7pm. Sharon seconded the motion and the motion passed unanimously.

Ongoing Business:

Website - Nothing to Report

Yard of the Month – On hold until next season – beginning in March 2010.

The following items were tabled for future review:

Late fee procedure – No progress this month. This has been placed on hold until the future Board is able to review the procedure.

HOA logo – No progress this month. We would still like to have a logo for an HOA entrance flat and for stationary. An idea was posed to put this in the newsletter and seek homeowner input for logo suggestions. This will be reviewed by the upcoming Board.

Park improvements – No progress this month. Suggestions for park improvements need to be solicited from the homeowners – some ideas are a playground, picnic tables, tennis court, and swimming pool.

New Business:

Budget – Scott presented and made motion to accept the revised budget based upon the updating of the files into Quickbooks. Sharon seconded the motion and the motion passed unanimously.

Flag pole lighting - The approval of the flag pole lighting was placed on hold pending another price proposal from one of Lonnie's contacts.
