Texas Legislature Alters HOA Regulations

During the last session of the Texas Legislature a number of bills were passed and signed into law that dealt with regulations governing Home Owner Associations. In fact, there were 32 such laws that address various aspects of the rules under which HOAs in Texas operate. Among these thirty-two laws the Legislature set three different "effective" dates.

In an effort to stay in compliance with the totality of the new laws, The Castle Hill Board has been in consultation with the attorney who helps us with this type of issue. There will need to be some changes to our By-Laws and Declarations. Any changes to those documents require approval by 67% or 75% (depending upon if it is the By-Laws or Declarations) of the community members.

Recently each member of the community received an envelope containing the proposed changes to the By-Laws and Declarations.



Included in that envelope was a letter announcing a special called meeting of the HOA membership on May 29, 2012 at Centerpoint Church, 601 SW Alsbury at 6:30 PM. The purpose of this meeting is to review, discuss, and vote on the proposed changes to make us compliant with the new laws.

In addition, the envelope contained a Proxy form for members unable to attend the meeting..

As mentioned previously, a high percentage of members must be present in person or via Proxy in order to make changes to comply with the law. Please make plans to attend for follow the directions on the Proxy sheet.

Long Term Planning Committee Report

At the August 2011 Community Meeting, a committee formed to explore long term needs and plan for the community. Fred Terasa volunteered to head up the committee and coordinate its efforts.

The committee examined nine questions and addressed each in

the report:

I. How can we maximize the potential and benefit of our financial resources and common areas?

2. How do we inspire residents to serve on Boards and Committees?

3. How can we encourage residents' interest in being involved

in community events?

4. What is the best way to demonstrate to home owners that compliance with Deed Restrictions increase property values?

- Reference to members' rights to inspect books and records of the HOA.
- Guidelines for Alternative
 Payment Plans on assessments.
- Information on the placement of Liens on properties by the HOA.
- Provisions for the foreclo-

sure process. This is a rather large segment on pages 11-13.

- Information on Use Restrictions relative to solar energy panels, rain water harvesting, and display of flags and banners.
- A number of items were deleted for several reasons. These are in green print in the copies you received in the mail.

May in Texas History

- May 13, 1865 -- The last land engagement of the Civil War was fought at the Battle of Palmito Ranch in far south Texas, more than a month after Gen. Lee's surrender at Appomattox, VA.
- May 16, 1888 -- The dedication of the present state capitol in Austin ended seven years of

planning and construction. The building was funded with 3,000,000 acres of land in north Texas.

- May I, 1718 -- San Antonio de Valero mission, known as the Alamo was the chapel, is founded in San Antonio.
- May 14, 1836 Santa Anna and Texas' provi-

sional president David Burnet sign two Treaties of Velasco -- one public, the other secret -- ending the Texas Revolution. The treaties were, however, violated by both sides. Texas' independence was not recognized by Mexico and Texas' boundary was not determined until the Treaty of
