## **Talkin' Trash**

Regular trash collection for Castle Hill homes is on Mondays and Thursdays, with recycling also collected on Thursdays. Trash collection may begin as early as 7 a.m., so be sure it's out on time, but City ordinance prohibits setting it out more than 12 hours ahead of that.



**Daylight Savings** Time ends **November 7**. so it's time to "fall back" an hour. Reset your clocks, and all light and sprinkler timers. Be sure to replace the batteries in your smoke alarms as well!

The special/bulk collection days for this neighborhood are the third full week of each month. Have all of your bulk items out at the curb by

7 a.m. on the third Monday.

Crews will work throughout

the week to pick up bulk

items, but they may not be

picked up until later in the week, and they may not all be picked up the same day.



### Know (and follow) the Water Rules

There is no denying it has been a long, hot summer. But we must still keep in mind that there is a City ordinance (Ordinance B-768-07) on the books limiting outdoor irrigation to specific times of day, and a number of homeowners are in violation of it regularly.

It is a violation to water lawns and landscaping using an irrigation (sprinkler) system between 10 a.m. and 6 p.m. That rule applies every day, all year round, for both residential and commercial properties. Any person, firm, or corporation who does not comply with the water conservation requirements laid out in the City Code is subject to fines up to \$500 per violation. The purpose of this regulation is to prevent wasting our precious water resources by watering during the heat of the day, when much of that water is lost to evaporation. Watering between 10 a.m. and 6 p.m. is only allowed if done with a hand-held hose or a soaker hose.



So please check the clock controlling your sprinkler system and make sure it

is set to run your system between 6 p.m. and 10 a.m. The best time of day to water your lawn is "by the dawn's early light," before 10 a.m.

Also be sure you check your sprinkler heads regularly to make sure your system is really watering your lawn and landscaping; not the sidewalk, driveway, or street.

## **Halloween Hints**

Castle Hill typically sees its fair share of trick-or-treaters on Halloween night. Please be sure to drive carefully through the neighborhood that night, as the little ghosts and goblins running into the street may not be able to see you.

If you have pets, please be sure to keep them properly secured on Halloween night. Even the calmest, most docile pet can become frightened by all the unusual noises, people, and costumes that will approach your doorstep. Pets who have never run away before might escape out the door while you hand out candy, and those that have never even growled at a stranger might bite a child in fear. Protect your pet, yourself and the visiting kids by keeping your pet secured in a room away from the front door.

If your kids will be out trick-or-treating, be sure they are wearing reflective material and/or carrying some sort of light so that drivers can see them clearly. And, as always, be sure you inspect their confectionary haul to be sure they aren't eating any candy that is already opened, spoiled, or may have been tampered with.

If you do not plan to hand out candy at your house this Halloween, please turn your porch lights off as a signal to visiting families.

According to the City of Burleson's website, the City's contractor will observe the following holidays: New Years Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day.

There are no special "makeup" collection days following a holiday.
