Calling Special Meeting of CHHOA


A Special Meeting is being called for the purpose of re-adopting the HOA's by -laws. The meeting will be held **Tuesday March 9**, **2010**; **6:30-7:00 pm.** at the park on Castle Hills Drive.

It has come to the Board's attention that the by-law document for the HOA is not signed. The by-laws outline how our HOA

operates. The Board has attempted to locate a signed copy; but to no avail. Therefore, the Board is proposing to officially re-adopt the HOA's current by-laws without any modifications.

To do this, we must call a Special Meeting and have the members vote. As stipulated by our incorporation documents, we must have **75%** (or 57 Homeowners) approve of the measure.

All homeowners should have the current copy of the by-laws. These were given to each homeowner at the time of their closing for their property and the same **copy** is on the website. Changes and modifications to the by-laws will not be entertained (cont'd on p. 4)

Lonnie and his fiancé moved into the neighborhood this past summer. They live at 300 Flagstone. He is a real estate agent for Keller-Williams, and they both have skills and experience that can be utilized to the benefit the neighborhood and the HOA Board.

At our first meeting, held on September 10, we held the election for the new board members. I was elected as President; Lonnie was elected as Vice President; and Sharon will serve as Secretary/Treasurer. Each member elected will be working within their strengths and should be an asset to the Board

Report from the Annual Meeting

At the annual meeting, the HOA members were apprised of the previous accomplishments that had occurred in the past year including:

- Communications: completing the Website with continuous updates and sending out the Newsletters on a quarterly basis.
- Flag Committee: establishing this new committee of volunteers, Dann Munro and Charlie Osborne, who hang the flags at the entry on flag days.
- Gas Lease Signing and Update
- Maintenance: including the fence repairs at the park; fire hydrants painted and a new sign at the entry.
- Policies and Procedures developed for Board Members
- Yard of the Month resumption
- Landscaping: continual excellence

The annual assessments will remain at \$264 and were due by January 31. Late penalties were assessed beginning on February 1. In addition, a new collection policy was presented with a few comments and questions as to the reason. The policy is in the process of a final legal review by an attorney and will be implemented for the 2010 year.

During the meeting, some members expressed a concern about:

- The number of rental properties within the neighborhood and the possibility of attempting to limit the number. There are numerous issues that would need to be pursued. This may be reviewed by the future Board.
- Opening an Interest Bearing Account for the Gas Lease money.
 In October, the Board opened a

money market account for the reserve funds and the gas lease monies.

Also at the annual meeting, there were drawings for a few door prizes. Several homeowners received a \$25 gift card to Babes, Chili's and Home Depot; and a box of Kitchen-Aid goodies graciously donated by Tom and Danielle Helfrich. THANKS Tom and Danielle!!!



The Board would like to remind all residents that signage in front yards is prohibited, unless for sale, temporary election or school spirit. Please see Article 7.12 (q) for details in Declaration of Covenants, Condition & Restrictions.

There were a number of issues with prohibited signs in yards during the fall holiday season. Please inform any vendors doing business at your home about this aspect of the HOA by-laws.



Special/Bulk Trash Collection

Confused about the special/bulk trash collection schedule for our neighborhood? Castle Hill is part of what's designated as Zone 3 by the City's Solid Waste Division. According to the City website, we should "...have all items out to the curb by 7:00 AM the **third Monday of every month**. Crews will work throughout the week clearing your zone of all the items. Your items may not all be picked up at the same time or by the same vehicle, depending on the items, some will go to the land fill and others may go to the compost center." Regular trash collection is on Mondays and Thursdays, with recycling collection on Thursdays. Recycling bin lids are available at the City
