Castle Hill Infrastructure Improvements

The CHHOA board, in cooperation with the Grounds Committee, has taken the following actions in an effort to brighten up the neighborhood as well as bring us up to City Code.

- 1. Completed a contract with a new lawn maintenance company, effective January 1, 2013.
- 2. Contracted for repainting of all lamp posts green with black tops. Anticipated completion: February 1, 2013.
- 3. Established an agreement with the City of Burleson to:
 - Remove HOA wooden street signs and stop signs
 - Repair of sidewalks after removal
 - Replace and emplace standard City street signs and stop signs

Anticipated Completion: 2013.*

In light of these recent and upcoming upgrades to the beauty of Castle Hill Estates and the approach of Spring, your HOA Board respectfully suggests that each Homeowner take a look at their Mailbox in an effort to make them look brighter! 
Correction to January Newsletter

Piccolini (mini farfalle) with Spinach and Bacon

INGREDIENTS:

- 1 (12 ounce) pkg piccolini (mini farfalle)
- 1 tablespoon olive oil
- 2 tablespoons minced garlic
- 6 slices bacon, chopped
- 1 (14.5 ounce) can petite diced tomatoes
- 1 bunch fresh spinach, (rinsed and torn into bit-sized pieces

DIRECTIONS:

- 1. Bring a large pot of lightly oiled and salted water to boil. Add the pasta and cook until tender, about 7-9 minutes.
- 2. Heat 1 tablespoon of olive oil in a large sauté pan over medium heat. Place bacon in the pan and cook until browned and crisp. Drain excess oil, if necessary, leaving approx. 2 tablespoons and add garlic. Cook for 1 minute. Stir in the tomatoes and simmer.
- 3. Place the spinach into a colander and drain the hot pasta over it so it is wilted. Transfer the pasta/spinach to bacon/tomato blend and toss until it is heated throughout.

Serve with fresh 'seasoned' bread and steam vegetables (broccoli) or salad.

Did you know?

Did you know that if you plan to add new or make modifications to the features of your home, you need to submit a request to the Architectural Control Committee (ACC)?

Article X, section 6, Amended and Restated Declaration of Covenants states:

"...Except as otherwise specifically provided herein, prior to (i) the commencement of any construction of any improvement on the Property or any portion thereof, or (ii) any change, alteration, addition or removal of any improvement other than normal maintenance and repair which does not materially alter or change the exterior appearance, condition and color of same, the plans and specifications therefore shall be submitted to the Committee..."

For example, if you have plans to create a new flower bed or modify the paint scheme of your home, you need to submit an ACC request for review prior to the work commencing.
