From the CHHOA Board

Our Annual Meeting was held August 21, 2008 at Albsury Baptist Church. We had a good turnout, with the quorum met and exceeded. We appreciate all of you who attended and represented our neighborhood at what is an important part of the HOA. This year we had to nominate one new board member to replace Dave Pronger. Thank you to Dave for all of his years of service in the neighborhood serving on the ACC and as a member of the Board of Directors. Thanks Dave!

As we look forward to a new term we enthusiastically welcome Scott Atwood of 916 Bridle Path to the Board! We are glad to have some representation from up the hill. Scott brings a fresh new perspective and will be a great asset with his experience as a business owner and also from him serving in the community at his church. Scott and his wife, Melinda, have lived in the neighborhood since 2004 and they have two children; one in college and one attending Burleson High School.

At our first meeting held on September 2, we held the election for the board members. Two positions will remain the same with Raina Smith as President and Karen Tucker as Secretary/Treasurer. Scott Atwood will serve as Vice-President. Of course, we are grooming Scott to take over next year when Raina and Karen will have served their full terms.

At the annual meeting the HOA members addressed new procedures that the board had adopted during the year.

- 1. The annual assessments will remain set at \$264 and are due by Jan. 1. For payments not received by Jan. 31, late fees will be assessed. For more information about the new late fee structure, *see the related article on page 3.*
- 2. The Board proceeded with retaining the lawyer the previous Board had identified and we had her review the Bylaws and Covenants. She indicated they were in good order and did not find any major discrepancies that needed to be resolved.
- 3. ACC Committee After all his hard work and effort, Paul Holton coordinated with the original com-

pany who supplied the park benches to get the slats replaced under warranty, free-of-charge. Thanks Paul!!!! We know you worked hard bird-dogging this issue.

During the meeting some members expressed a concern regarding the aesthetic appearance of some lawns in our neighborhood. This is an issue that continues to be a nuisance. Please see the related article on page 3 for more information from the board on this issue, as it directly affects all properties within the HOA and everyone's help is needed to address the problem. Also of concern was the fact that, periodically, someone might park a trailer in the drive or on the street for longer than a day. However, this is a violation of the HOA Covenants, and homeowners need to take care to meet Castle Hill's parking requirements.

Another issue raised at the meeting was the water at the front entry being on too much during the recent heavy rains. The Board had contracted with Webb Landscape Management to maintain the irrigation system during the hot, hot summer months, and they had not yet been by to adjust the water. However, since the meeting, the front entry irrigation issue has been addressed.

Sheri Campbell-Husband took over the Communications Committee position this year and brings great experience, having done similar work previously in her job with the City of Burleson. She is a great asset and has a lot of information to share regarding what is going on in the whole Burleson community.

Next Spring we will resume the Yard of the Month recognition. When the website is up we will have a section where anyone can nominate a yard that they think is deserving of the Yard of the Month honor. The much-deserved winner will get a great reward.

After three great years, Kathy Roden has decided to hang up her social coordinating hat for a while. It goes without saying that if she had not been Social Committee chair there would not be a social committee. We were blessed to have her volunteer in this capacity. As indicated in the mail-out for the annual meeting, we are looking for someone to volunteer for this committee position or volunteer to coordinate a specific event. No one volunteered at the annual meeting to chair this committee or to chair either the Fall Festival or Progressive Dinner, so we will not have a Fall Festival this year. If anyone would like to coordinate all or part of the Progressive Dinner, please contact Raina Smith to indicate your interest. If no one volunteers to coordinate the Progressive Dinner this year, we may elect not to have the dinner either. But it sure would be a shame to give up that opportunity for us all to get to know each other better!

Landscaping Tops Homeowners' Concerns

At the Annual Meeting, the issue of landscape and lawn maintenance (or lack thereof) was a hot topic. According to the Covenants (Section 9.1 - excerpt), "the Association may at its option, have the grass, weeds and vegetation cut as often as necessary in its judgment, and the Owner of such Lot shall be obligated, when presented with an itemized statement, to reimburse the Association for the cost of such work."

The most frequent violation of the restrictions is allowing grass and weeds to grow taller than the 6-inch limit. This maximum height includes both the lawn and flower beds. The Board appreciates you keeping your lawn maintained, as it is a courtesy to your neighbors and keeps our neighborhood attractive.

violating the grass height restriction, a member of the ACC or the Board may opt to contact the homeowner by sending a letter requesting the property be mowed within 5 days. If it is not mowed, the HOA will hire someone to cut the lawn and will then present the homeowner with a bill to reimburse the HOA.

The letter is a courtesy to the homeowners reminding them of the restrictions in the Covenants with regard to lawn maintenance and landscaping. The ACC has been keeping an eye on those who are in violation and has been sending letters.

Please have enough respect for your neighbors and yourself to maintain your landscaping so that the volunteers who

serve on the committees and the board do not have to go to these measures. We all want to have an attractive and aesthetically pleasing neighborhood!

- Any cat not confined to its owner's home, vehicle, or property to be on a leash or in a carrier and under the control of its owner.
- showing proof of current rabies vaccination at all times.
- if it is left on someone else's property.

This is a pet-friendly community, but pet owners must make sure they take proper care to protect their pets and the public from unsafe situations.

Dues and Late Fees Explained

Decisions regarding annual dues for the CHHOA have been an important part of Board activity this year. The annual dues assessments will remain set at \$264 and dues payments are still due by January 1 of each year. For payments not received by January 31, late fees will be assessed according to the following structure.

On February 1, a one-time late fee of \$50 will be assessed. For each month thereafter, an additional late fee of \$25 will be assessed at the first of the month. Payments received will be applied first to late fees then to assessments. For example, if an annual assessment is not received as of March 31, the total assessments, with fees due on or after April 1, will be calculated as follows:

| \$264 | Annual dues |
|-------|-------------------------------|
| \$ 50 | Late fee (Feb. 1) |
| \$ 25 | Monthly late fee (Mar. 1) |
| \$ 25 | Monthly late fee (April 1) |
| \$364 | Total due |

Please be aware that the board will not accept any installment payment plans for annual dues assessments. To reduce the administrative workload for the volunteer board, annual dues, including any late fees, must be made in a single payment.

The new late fee structure was reviewed by the HOA attorney and was found to comply with the HOA bylaws. If you have questions regarding the new fee structure for late payments, or if you don't receive you dues invoice by December 25, call Secretary/Treasurer Karen Tucker.
